The customer confirms that by applying for Berhan Mobile Banking service he/she accepts all the terms and condtion presented herein below.

- ለመጀመሪያ ጊዜ ደንበኛው የአንልግሎቱ ተጠቃሚ ለመሆን ከአንልግሎቱ ጋር እንዲያያዝለት በጠየቀው የተንቀሳቃሽ ስልክ ቁጥር በአጭር የጽሁፍ መልእክት አማካኝነት ጊዜያዊ የግል መለያ ቁጥር ይሳካል:: ደንበኛው መመሪያውን በመከተል ጊዜያዊ የግል መለያ ቁጥሩን በፍጥነት መቀየር ይኖርበታል በተጨማሪም መመሪያውን በመከተል የሚስጥር ቁጥር ቃል መፍጠር ይኖርበታል::
- •• ማሳሰቢያ:- የሚስጥር ቁጥር ቃል ለበለጠ ጥንቃቄ ሲባል ከግል ሙለያ ቁጥር በተጨማሪ የደንበኛውን ማንነት ለማረ*ጋገ*ጥ ይጠቅማል::
- •• An SMS with temporary PIN (Personal identification number) will be sent to the mobile number of which the customer gave to the Bank on its first time registration. The customer has to follow the step and change its PIN immediately. In addition the customer has to follow the instruction from its mobile has to create its own security code at first time of login.
- N.B:- For security reasons in additions to the PIN number the security code is used to identify the customer further.
- •• For security reason the customer has to change to change its PIN number as soon as he/she gets's he SMS. Beside this the customer has to change its PIN and security code periodically.

- •• The customer is obligation to keep safely its PIN and Security code. In case the customer violate its obligation and where there is a related loss the customer will be liable to cover the loss. Bank will not be liable to cover such loss.
